

In-Kind Membership Services

Membership Entities and Participants as defined in the *PGO16 2015 By-Laws* and in *BCWA Policy 16 Membership* support the program by providing various types of in-kind services and costs. These in-kind services and costs are essential in reducing the overall program and monitoring costs covered under the annual Cost Share Program (*BCWA Policy 33 Cost Share Program*). The types of in-kind services and costs include, but are not limited to:

- 1. Staff support to assist the Manager with field sampling at Bear Creek Reservoir, Evergreen lake, and the watershed sites. Field support includes water quality sampling, macroinvertebrate collections, habitat and physical site surveys, and temperature probe placement and data collection and Data Report. Staff also helps with BCWA special projects and programs (e.g., sign placement and maintenance). Boats are provided for both the Bear Creek Reservoir and Evergreen Lake sampling. Members cover the cost of operation and maintenance of boats and the placement of buoy's in these waterbodies. Membership Entities assist with transfer of water samples to the BCWA contract laboratory.
- 2. Membership Entities provide meeting space for Board, Technical Review (TRS) sessions, special watershed related meetings, presentations, webinars and training courses.
- 3. Membership Entities have provided supplies and equipment for projects to support the monitoring program with no bill-back to the BCWA.
- 4. Membership Entities have helped order and fronted the costs for supplies and equipment with bill-back to the BCWA.
- 5. Membership Entities and Participants have assisted with educational and training programs in support of Earthday, water festivals, classroom instruction, scouting projects and other educational programs.
- 6. Membership Entities and Participants have assisted with pollution prevention and reporting.
- 7. Membership Entities have provided staff for regulatory presentations to the Water Quality Control Commission and meetings with the Water Quality Control Division staff.

Major In-Kind Membership Entities Program Supporters

- 1. The City of Lakewood provides staff that directly supports monitoring at Bear Creek Reservoir, provides sampling boat/ operator, periodic watershed sampling assistance, supplies and equipment, and provides meeting space for the TRS. The annual in-kind services and cost provided by Lakewood is estimated at \$13,250.
- 2. The Evergreen Metropolitan District provides staff that directly supports monitoring at Evergreen Lake, the watershed sampling program, the temperature monitoring program, and provides meeting space for the Board and other meetings. The annual in-kind services and cost provided by EMD is estimated at \$18,625 per year.
- 3. The West Jefferson County Metropolitan District provides staffing that directly supports monitoring at Evergreen Lake, the watershed sampling program, the temperature monitoring program, and data processing. The annual in-kind services and cost provided by WJCMD is estimated at \$15,000 per year.
- 4. The Kittredge Water and Sanitation District provides staffing that directly supports monitoring at Evergreen Lake, the watershed sampling program, the temperature monitoring

program, and data processing. The annual in-kind services and cost provided by KWSD is estimated at \$3,000 per year.

5. Morrison provides staff that support the special copper monitoring program near Morrison. The annual in-kind services and cost provided by Morrison is estimated at \$1,325 per year.
