Fact Sheet 13 Watershed Management Makes a Difference Update June 6, 2016

Bear Creek Watershed Association has 32-years of active service to the Watershed in Clear Creek, Jefferson and Park Counties

- BCWA spent >2.1 million on regulatory mandated programs
- Members have spent 1.4 million on data and monitoring efforts
- Discharger members have spent >24 million dollars on wastewater treatment plant upgrades
- Treatment plants have an exceptional compliance history
- Some dischargers voluntarily monitored streams
- Members spent >2 million on water quality related practices
- The Association has made over 76.7 years of voluntary efforts
- 29-years of data and studies have supported good science

Management Practices Contribute to Measureable Water Quality Improvements Bear Creek Reservoir over Last 25-years

- Reduced Chlorophyll on average by 8 ug/l
- Reduced Nitrate-nitrogen on average by 200 ug/l
- Reduced Total Phosphorus on average 125 ug/l
- Reduced Total Suspended Sediments on average 3,000 ug/l
- Improved Dissolved Oxygen, meets standards
- Reduced peak phytoplankton densities by 93%
- Removed >800 tons of Nitrate-Nitrogen
- Removed >400 tons of Total Phosphorus
- Removed >350,000 tons of Total Suspended Sediments

Management Practices Improve Fishery

- 2.6 million measurements and over 99% temperature compliance
- Reduced watershed nutrient load
- Extensive County stromwater improvements
- Increase of total trout biomass by 17 times since 1988
- In last decade, Brown Trout biomass increased 300%
- Bigger fish—Brown trout over 24 "; Greenback Cut-throat > 21"; Rainbow Trout > 21", Small mouth bass >23"
- Fishery pressure in watershed over last decade has tripled
- Estimated 65,000 fishing persons per year visit watershed

Better county and other local regulations = **Better Water Quality**

- Use of best management practices
- Keeping water onsite and stormwater management
- Manure management
- Improvements to onsite wastewater treatment (septic) regulations
- Groundwater studies
- Community Plan Development recognize importance of water quality
